

WESTVILLE-BELGIUM SANITARY DISTRICT

AN ORDINANCE AMENDING ORDINANCE NUMBER 82-4

WHEREAS, the Board of Trustees of the Westville-Belgium Sanitary District of Vermilion County, Illinois (hereinafter the Board) has heretofore approved and adopted an Ordinance establishing the schedule of rates and charges to be collected by the Westville-Belgium Sanitary District (hereinafter the District) from users served by the sewage works of the District and other matters connected therewith, known as Ordinance Number 82-4, as amended from time to time (hereinafter the Ordinance); and

WHEREAS, the Board has determined that it is necessary and in the best interests of the District and its users to amend a portion of the Ordinance.

NOW, THEREFORE, be it ordained by the Board of Trustees of the Westville-Belgium Sanitary District of Vermilion County, Illinois, as follows:

FIRST: Section 200.1, Paragraph A, of Article II - Establishment of Rates is hereby removed and replaced as follows:

- A. All Users located within the service area of the District shall pay monthly at a rate of \$5.06 per 1,000 gallons of the water usage of or by each premises owned by, leased by, or located on the User's property that discharges waste to the District with a minimum charge of 2,000 gallons per month. The quantity of monthly water usage shall be determined by the water meter records of either the Westville Gas & Water Department of the Village of Westville, Illinois, or Aqua Illinois, Inc. or their successors who provide water service.

SECOND: Section 200.1, Paragraph C, of Article II - Establishment of Rates is hereby removed and replaced as follows:

- C. Where water service is not provided by either the Westville Gas & Water Department of the Village of Westville, Illinois, or Aqua Illinois, Inc., or their successors, the User shall pay a rate of \$17.41 per month for each premises that discharges waste to the District.

THIRD: Section 200.2 of Article II - Establishment of Rates is hereby removed and replaced as follows:

Section 200.2. All Users located within the service area of the District shall pay \$6.80 per month for general uses and purposes of the District, including defraying the costs of capital improvements and debt service.

FOURTH: Section 200.3 of Article II - Establishment of Rates is hereby removed and replaced as follows:

Section 200.3. RESERVED FOR FUTURE USE.

FIFTH: Section 200.5 of Article II - Establishment of Rates is hereby removed and replaced as follows:

Section 200.5. All Users shall pay a minimum fee of \$16.92 per month, calculated as the total of the minimum charges due under Sections 200.1 and 200.2 on each and every lot, tract, parcel, structure, building, house, residence or part thereof, improvement, apartment, multi-family dwelling, apartment unit, trailer, modular home, mobile home, mobile home park, mobile home pad or pod, which is connected with the District's sewer system or otherwise discharges sanitary sewage, industrial waste or other liquids directly or indirectly into the sewage system of the District. Said minimum fee per month shall also apply where each lot, tract, parcel, structure, building, house, residence or part thereof, improvement, apartment, multi-family dwelling, apartment unit, trailer, modular home, mobile home, mobile home park, mobile home pad or pod is vacant, abandoned or unoccupied by the User or occupant at any time during the billing period.

SIXTH: Section 501 of Article V - Billing for Rates and Surcharges is hereby removed and replaced as follows:

Section 501. User rates and other charges and surcharges shall be computed and billed each month on each lot, tract, parcel, structure, building, house, residence or part thereof, improvement, apartment, multi-family dwelling, apartment unit, trailer, modular home, mobile home, mobile home park, mobile home pad or pod by first class mail at and for the rates, charges and surcharges set forth in this Ordinance. The bill for the User rates, charges and surcharges shall be due and payable in full on the third (3<sup>rd</sup>) day of the month following the month of mailing, or the next business day in the event the 3<sup>rd</sup> day falls on a weekend or holiday. The User rates, charges and surcharges mailed in a given month are for services rendered by the District for the previous month.

SEVENTH: This Ordinance shall be in full force and effect upon its passage and publication.
